League Rules met in determining promotions & relegations:

Rule 11.1.3 2 up and 1 down in both sections (2010 only) in order to increase Premier to 10 teams.

Rule 10.5 Vacancy in Div3 West following **Goldsithney** withdrawal prior to 2009 season resulting in **no one relegated** from 3 West to 7 West inclusive

Premier **Gramp Rd & Penzance promoted** - **Callington reprieved.**
County 1 **Beacon & Roche promoted** - **Falmouth 2 & Bude reprieved however Bude relegated # by request with Menheniot Looe thus promoted # as Div 2 East runner-up.** Div2 West runner up Rosudgeon declined the offer to be considered for promotion. (Menheniot have become Menheniot Looe following a merger between the clubs)

2 West **Constantine & Crofty/Holman promoted** - **Wendron only relegated**

3 West **Praze & Helston promoted** - **Troon 2 reprieved** due to vacancy through **Goldsithney** withdrawing .

4 West **St Ives & St Newlyn East promoted** - **St Day reprieved** due to vacancy above **but relegated by request with Mullion 2# thus promoted**

5 West **Crofty/Holman 2 & Gulval 2 promoted** (as **St Just 4 ineligible under Rule 10.4**) - **Mt Ambrose 2 reprieved** due to vacancy above.

6 West **St Ives 2 & Praze 2 promoted** - **Wendron 2 reprieved** due to vacancy above.

7 West **New teams accepted: Gerrans 2, Goldsithney 2. Botallack 2 withdrawn and Penzance 3 application withdrawn . Total 9 teams .**

2 East **St Minver & Boconnoc promoted** - **Lanhydrock relegated by request thus Newquay 2 #also promoted following Bude withdrawal.** (Looe have become Menheniot Looe 2 following merger)

3 East **Callington 2 & South Petherwin promoted** - **Launceston 2 relegated by request thus St Austell 3 #also promoted**

4 East **Tregony & Roche 2 promoted** - **Fowey 2 reprieved** due to vacancy above.

5 East **Delabole & Duloe promoted** - **Menheniot Looe 4 relegated (ineligible under Rule 10.4)** thus **Callington 3# also promoted to fill vacancy.** (Menheniot 2 become Menheniot Looe 3 following merger)

6 East **South Petherwin 2 & Wadebridge 3 promoted** - **Bude 3 (now Bude 2) reprieved** (Looe 2 become Menheniot Looe 4 following merger)

7 East **New teams accepted: Grampound Rd 4, St Stephen 2.** Werrington 5 inclusion was subject to Rule 17.3.2 being amended (failed to reach 40% again . **Total 11 teams**

Since the Divisions were published in late November the following has happened during December. The issues have been resolved over the Christmas with grateful thanks to the clubs listed in bold below for their prompt responses.

Botallack 2 have withdrawn from **Div 7 West**

Penzance 3 have withdrawn their application to rejoin **Div 7 West**.

Bude have withdrawn their first XI from **Div 2 East** to take the place of their seconds in Div 4 East, thus withdrawing their third XI from the league.

In order to fill the vacancy in Division 2 East, following consultations with all the clubs involved, the following will now take effect for 2010.

Newquay 2 – are additionally promoted to **Div 2 E** (Lanhydrock having already stated they did not wish to be reprieved relegation in order to rebuild in Div 3)

Launceston 2 – having not won a game in 2009 wish to be relegated to rebuild in **Div 4 E**
St Austell 3 are therefore promoted to **Div 3 E** as third placed finisher.

Fowey 2 are reprieved relegation from **Div 4 E**

Callington 3 are promoted to **Div 5 E** as third placed finisher (Menheniot Looe 4 ineligible to be reprieved under Rule 10.4)

Bude 2 (formerly 3) reprieved relegation in **Div 6**.

The fixturing process is now able to commence as it can only be done as a whole once all divisions (east and west) are finalised. **Needless to say if any other club envisages withdrawing a team before February please inform immediately.**
